**Motorcycle Touring
Liability Waiver and Release**

Inherent Risk of Motorcycle Touring - I hereby represent and acknowledge that I am fully knowledgeable of the danger and hazards associated with riding motorcycles, including the possibility of incurring severe personal injury, major property damage and even death. I am duly licensed and possess the abilities and skills necessary to operate a large (over 750 cc) motorcycle in a safe and cautious manner, and I accept full, complete and personal responsibility for the safe operation of my motorcycle while participating in the Tour. I, my dependents, heirs and assigns hereby release and hold harmless GAMCT and any staff members of the company against any and all claims, causes of action, or any other liability of any kind arising from my activity of touring by motorcycle. I know of no physical or mental impairment that may affect my safety or the safety of my passenger or the group.

Safety - On every GAMCT Tour, the safety of our participants and staff is of the ultimate importance. If at any time I feel that motorcycles are being operated in an unsafe manner, or that safety is being compromised in any way, I will bring it to the immediate attention of the Tour Leader, so my concern can be promptly addressed. While on the Tour, the decision of whether or not I wear a helmet or other protective equipment is solely my own and I will be responsible for compliance with all state laws, including those regarding use of helmets and other safety equipment. However, I acknowledge that GAMCT STRONGLY URGES the wearing of a helmet and safety equipment, such as abrasion resistant clothing, gloves, boots and eye protection, AT ALL TIMES, regardless of the law. Further, I certify that I will not at any time during the Tour operate a motorcycle under the influence of alcohol, narcotics, or other substances which may impair my ability to operate a motorcycle safely. Any person found to be operating a motorcycle or other vehicle while under the influence of any such substance may be dismissed from the Tour immediately, without refund or credit of any kind.

Insurance - I understand that the supplied VIP Coverage on hired motorcycles, optional Supplemental Liability Insurance (SLI) and Commercial Liability insurance maintained by Great American Touring Group, Ltd. are not a substitute for my own insurance protection while traveling in the US and Canada. VIP coverage WILL NOT PAY for property damage or injury to the Rider, Passenger or any Third Party - it will pay ONLY for loss or damage to the motorcycle. SLI insurance WILL NOT PAY for Property Damage or Injury to the Rider or Passenger. It will pay ONLY for property damage or injury to a THIRD PARTY.

VIP, SLI and Commercial Liability coverages held by GAMCT DO NOT provide Personal Accident / Illness / Injury Insurance. Tour Participants must secure their own insurance protection in the event of injury or death - by any cause including motorcycle accident - or illness while away from home. I will consult with my own insurance advisor if I am uncertain as to what additional coverage, if any, I may decide to purchase.

Unforeseen Circumstances and Force Majeure - I agree to hold GAMCT harmless for any for failure, delay, acts of omission or commission and any resulting loss or damage occurring during the Tour, or as a result of the Tour, through the actions of third parties, including, but not limited to, the operators of hotels and restaurants, carriers, and other suppliers and vendors engaged by GAMCT. This includes damage or loss due to governmental action, weather, mechanical breakdown, equipment failure, labor disputes, sickness, acts of War, acts of God, or other causes beyond the direct control of GAMCT.

Terms and Conditions

Payment - A deposit of \$500 per person is necessary to hold your place on a Tour. The full tour price must be paid in full no later sixty (60) days before the tour. GAMCT may cancel your reservation if payment is not received by that time. All prices are in US dollars. We accept MasterCard and Visa for Reservation Deposits and Tour Fees. However, personal or bank check, Money Order, or Electronic Funds Transfer is preferred for final payment.

Refunds and Cancellations - Participants who cancel a reservation will receive refunds as follows: (A) More than 60 days before tour - Refund of deposit, less a \$250 fee per person. (B) Less than 60 days but more than 30 days before the tour - Refund of 50% of the tour price, providing the entire tour fee has been paid. (C) **No refunds for cancellations less than 30 days prior to tour date.** (D) If GAMCT cancels a tour, all the money you have paid to us will be refunded, or you may apply your payment to another tour. We cannot refund the cost of "non-refundable" airline tickets. If an alternate tour is selected, adjustments will be made for any difference in cost between the alternate and your original tour selection.

We strongly urge all participants to obtain Trip Cancellation / Trip Interruption Insurance to protect themselves from financial loss due to the unexpected cancellation or interruption of your Tour for reasons including (but not limited to) accident, illness, war, threat of war, political crisis, civil commotion or strife, terrorist activity, strikes or industrial action, natural disasters, fires, technical problems to transport, closure of airports or other circumstances, Acts of God or other events beyond the control of Great American Touring Group, Ltd.

Guests are also responsible for arranging suitable insurance to provide personal protection in the event of accident, illness or injury (motorcycle related or otherwise) while traveling in the US. The Collision Damage / Theft coverage included with rental motorcycles is NOT insurance that will pay for illness or injury, it is ONLY for the value of the motorcycle if it is damaged or stolen.

Our Responsibilities - All GAMCT tours are continually refined and updated to maximize the safety and enjoyment of our guests. We reserve the right to modify, without notice to tour participants, any tour as needed to accommodate operating needs or circumstances beyond our control. This includes, but is not limited to, hotel and dining arrangements, routes and itinerary. In the event substitutions are made, we will strive as far as practical to insure that all features of the tour are of similar or better quality than those originally planned. We will transport your luggage in our support vehicle and/or trailer, but accept no claims or responsibility for costs or damages related to lost or damaged baggage, other than to provide reasonable care and security for your property.

GAMCT is acting as your agent to obtain accommodations and meals, provide guide services, and will assist in obtaining a rental motorcycle for this Tour. GAMCT has no affiliation with any motorcycle rental, transport or storage company and does not assume responsibility for services (or lack thereof) provided for motorcycle rental, shipment or storage. GAMCT is held harmless against any and all claims, causes of action, or liability of any kind arising from the rental, transport, or operation of a motorcycle. Your selection of a specific motorcycle model is not guaranteed and substitution may be necessary.

Weather - We schedule our tours at times when weather is reasonably expected to be suitable for riding a motorcycle in the areas we are visiting. However, on occasion, we may be faced with unfavorable or severe weather, and we are not responsible for delays or modifications due to weather conditions.

Acceptance - These terms cannot be modified except in writing by an officer of Great American Touring Group, Ltd. My signature below, and/or payment of my deposit or tour fees constitutes acceptance of these Terms and Conditions. I have carefully read, understand and accept these Terms and Conditions.
